## KAYAK Rental Agreement – Hourly, Half Day, Daily

This agreement is entered into between Smith Point Marina, Inc., The OWNER, and the below listed individual, herein known as the RENTER. The RENTER agrees to the following conditions of renting one or more Kayaks:

- a. **RENTAL HOURS: 8AM TO 4PM DAILY.** Rentals are only made from the office at Smith Point Marina. We do not deliver KAYAKS to over the road destinations.
- b. **RENTAL SECURITY.** The renter will leave a copy of their driver's license in the Marina Office during daily rentals. Payment for the rental will be made upon return of the KAYAK to the Marina.
- c. **RENTAL FEE.**
  1. ONE PERSON - \$20 per hour, \$30 for half day (4 hours), \$40 for Full Day.
  2. TWO PERSON - \$30 per hour, \$40 for half day, \$60 for full day
- d. **SAFETY:**
  1. Renter agrees that all persons riding or paddling in the KAYAK will at all times wear their life jacket.
  2. Renter agrees that the Kayak will be navigated wherever possible OUTSIDE of navigational channels, avoiding all power boat traffic as much as possible.
  3. Renter takes full responsibility for any damage or injury to boat, equipment, or people caused by any reason and will hold harmless the RENTER in the event of damage or injury while operating, boarding or leaving the KAYAK.
  4. Limits of KAYAK travel. Smith Point Marina KAYAKS may only be used within the confines of the Little Wicomico River, upstream of River Marker Green 7. Under no circumstances mat the KAYAK be taken through the Little Wicomico River Jetties or into the Chesapeake Bay.
- e. **LOST/DAMAGED/STOLEN EQUIPMENT CHARGE:**
  - a. POLYETHELYNE/PLASTIC KAYAKS are by their nature extremely tough and not easily damaged. They are also not easily repaired. Any damage which renders the kayak un seaworthy in the opinion of the OWNER will result in the RENTER being assessed full replacement value (no depreciation) of the KAYAK. This cost will be set at \$600 for one person and \$1400 for 2 person KAYAKs
  - b. Loss or damage to paddles - \$50
  - c. Loss or damage to life jacket \$60
- f. **PICKUP CHARGE:** If for any reason the KAYAK or equipment has to be picked up by Marina personnel, there will be a \$50 pickup charge.
